<u>Jean-Eric Paquet</u> was the Director-General for Research and Innovation from 2018 and 2022, he set up the European Innovation Council and promoted a whole-of-government approach for R&I, notably via the creation of several EU Missions to solve major ecological, societal, and economical challenges. In all his endeavours, he puts co-creation and systemic change at the heart of the decision-making process, and strongly believes that citizens should be more involved in shaping public policy agendas.

Laurent Depus has had several ssenior leadership positions in the financial services industry for over 35 years in Europe, South-East Asia and since 1988, in Japan. Experience in Banking, Securities, Trust Banking and Wealth Management. From 2003, contributor to key discussions on business, regulation and governance matters at the International Bankers Association of Japan (IBAJ). Appointed as a

Director of IBAJ in 2012, Vice Chairman in 2020-2021, and Secretary General in 2024. Appointed as President of the European Business Council in Japan in January 2024. Ambassador for FinCity.Tokyo between December 2021- March 2024.

Ms. Hata-Knoblauch is co-founder and managing director of the Japanese Cultural Center in Frankfurt, Managing Director of the Association of Japanese Companies in Frankfurt as well as Board Member of the German/Japanese Society in Frankfurt. She is considered a driving force behind German/Japanese exchange.

<u>Valérie Moschetti</u> is Executive Director and COO at European Business Council in Japan. In the past, she has worked in the Ivory Coast, South Africa, and Morocco. She has an international career of 25 years in business development, strategy, and public affairs.

Japan has had a special place in <u>Johannes Beyer's</u> life for decades. The Frankfurt lawyer now advises Japanese companies and serves as president of the local German Japanese society.
